Page 15, Annex C, C.1 Background, a.1)

Include error margins for environmental conditions:

"environmental conditions: 20 °C, 50 % RH; 1 m/s wind;"

Becomes:

"environmental conditions: 20(±0,5)°C, 50(±5)% RH., 1m/s wind;"

Page 15, Annex C, C.1 Background, b.1)

Rectify the values for temperature during 3-phase profile:

"i. 60 minutes of constant temperature at 30°C without sweating"

Becomes:

"i. 60 minutes of constant temperature at 35°C without sweating"
