This amendment A1 modifies the European Standard EN 60335-2-25:1995; it was approved by CENELEC on 1997-03-11. The proposal to endorse amendment 1:1995 to IEC 335-2-25:1993, document CLC/TC 61 (SEC) 1023, was circulated under the enquiry procedure in June 1995. This proposal was discussed during the Copenhagen meeting in May 1996, when it was decided to submit a draft for an amendment to EN 60335-2-25 to the formal vote.

This draft was circulated in September 1996 and was ratified by CENELEC as amendment A1 on 1997-03-11.

This amendment has been prepared by the secretariat of CENELEC Technical Committee TC 61.

- date of withdrawal of
conflicting national standards (dow) 1999-06-01

For products which have complied with EN 60335-2-25:1995 before 1999-06-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2004-06-01.

This amendment supplements or modifies the corresponding clauses of EN 60335-2-25:1995.

There are no special national conditions causing a deviation from this amendment.
