## 1 Modifications to Clause 6

*In clause 6.101.1, modify the first paragraph as follows:*

"The standard test programme for noise measurements is "eco 40-60" washing programme related to EU regulation without pre-wash."

*Delete Note 101 and the second paragraph.*

*In clause 6.101.2, add a note Z1 at the beginning of the paragraph as follows:*

"NOTE Z1 For the purpose of energy labelling regulation (EU) 2019/2014 this drying period is not necessary to be measured and to be reported."

*In clause 6.101.3, add a note Z1 at the beginning of the paragraph as follows:*

"NOTE Z1 For the purpose of energy labelling regulation (EU) 2019/2014 this continuous cycle is not necessary to be measured and to be reported."

## 2 Modification to Clause 7, "Measurement of sound power levels"

*In clause 7.4.1, add a note Z1 at the begin of paragraph as follows:*

"NOTE Z1 For the purpose of energy labelling regulation (EU) 2019/2014 spinning period in "eco 40-60" washing programme is to be measured and to be reported only."

*Add a note Z2 after the third paragraph as follows:*

"NOTE Z2 Thermal spin is not to be considered for purpose of energy labelling regulation (EU) 2019/2014."

## 3 Modification to Clause 8, "Calculation of sound pressure and sound power levels"

*In clause 8.101.1, add a note Z1 after the first paragraph as follows:*

"NOTE Z1 For the purpose of energy labelling regulation (EU) 2019/2014 spinning period in "eco 40-60" washing programme is to be measured and to be reported only."
