1 Modification to Clause 6, "Operation and location of appliances under test"

In clause 6.101, modify the first paragraph as follows:

"The standard test programme for noise measurements is "eco 40-60" washing programme related to EU regulation without pre-wash.

Delete the second paragraph.

2 Modification to Clause 7, "Measurement of sound power levels"

In clause 7.4.1, add note Z1 after the first paragraph as follows:

NOTE Z1 For the purpose of energy labelling regulation (EU) 2019/2014 this washing period is not necessary to be measured and to be reported.

3 Modification to Clause 8, "Calculation of sound pressure and sound power levels"

In clause 8.101, add a note Z1 after the first paragraph as follows:

NOTE Z1 For the purpose of energy labelling regulation (EU) 2019/2014 this washing function is not necessary to be measured and to be reported.
