Foreword

A proposal to amend prEN 50088:1995 was discussed during the Paris meeting in November 1994 when it was decided to submit a draft for an amendment to the formal vote.

This procedure started in February 1995 (prAA) but due to the comments received a further discussion of the draft was necessary during the Dublin meeting in May 1995 where it was decided to submit the modified draft to the voting procedure.

This draft was circulated as prAB in July 1995 and was ratified by CENELEC as amendment A1 on 1995-11-28.

This amendment has been prepared by the secretariat of CENELEC Technical Committee TC 61.

The following dates are applicable:

- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement

(dop) 1996-06-01

- latest date by which the national standards conflicting with the amendment have to be withdrawn

(dow) 2001-10-01

For products which have complied with EN 50088:1996 before 2001-10-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2004-10-01.

This amendment supplements or modifies the corresponding clauses of EN 50088:1996.

14 Construction

Replace 14.2 by:

The transformer of transformer toys shall not be an integral part of the toy. Controls for the toy are not to be incorporated in the transformer.
