This document provides examples of Declaration of Performance (DoP) and CE Marking for bitumen and bituminous binders for use in the construction and maintenance of roads, airfields and other paved areas.

NOTE 1 Only harmonized technical specifications (product standards or ETAs) cited in the OJEU are the basis for drawing up the Declaration of Performance.

#### AVCP

Assessment and Verification of Constancy of Performance

### 3.2

#### CE Marking

marking by which the manufacturer indicates that the product is in conformity with the Declaration of Performance for the construction product

Note 1 to entry: CE Marking, in the scope of the CPR, is not a certificate of conformity, it stands for the commitment of the supplier to compliance of the construction product with its Declaration of Performance.

Note 2 to entry: Declaration of Performance and thereafter CE Marking are mandatory for any construction product falling within the scope of a European harmonized standard.

**4 Declaration of Performance (DoP)****4.1 General**

The Declaration of Performance is described in Articles 4 to 7 of the CPR (the Regulation (EU) No 305/2011).

**4.2 AVCP System 2+**

The manufacturer draws up the DoP and affixes the CE Marking on the basis of the applicable AVCP system. The applicable AVCP system for bitumen and bituminous binders for use in the construction and maintenance of roads, airfields and other paved areas is system 2+. Details on AVCP systems are outlined in Annex V of the Regulation (EU) No 305/2011 (CPR).

**4.3 Content**

The content of the DoP is described in Article 6 of the CPR. Annex III of the Regulation (EU) No 305/2011 (CPR) provides a model of the DoP. This Annex III was amended by Commission Delegated Regulation (EU) No 574/2014 of 21 February 2014.

This Regulation stipulates that the DoP for construction products covered by a harmonized standard shall contain the following information:

- the number of the DoP as foreseen in Article 9 (2) of Regulation (EU) No 305/2011 (CPR);
- the unique identification code of the product-type (may be the same as the reference number of the DoP);
- the intended use(s);
- the manufacturer (the name, the registered trade name or registered trade mark and the contact address of the manufacturer, as required pursuant to Article 11(5) of Regulation (EU) No 305/2011);
- the authorized representative (if applicable, see Delegated Regulation (EU) No 574/2014);
- the system/s of the AVCP (if there are multiple systems, each of them shall be declared);

NOTE In the case of bituminous binders only the system 2+ applies.

- the reference number of the harmonized standard and its date of issue (dated reference);
- the identification number of the Notified Body/ies;
- the list of essential characteristics, as determined in the harmonized technical specification (Annex ZA) for the declared intended use or uses;



- the performance of at least one of the essential characteristics of the construction product, relevant for the declared intended use or uses; for all other essential characteristics for which no performance is declared: NPD;
- the appropriate Technical Documentation and/or Specific Technical Documentation (if applicable, see also articles 36 to 38 of the Regulation (EU) No 305/2011 (CPR)).

For details, see Delegated Regulation (EU) No 574/2014, including the given instructions for drawing up the declaration of performance.

Regarding the supply of the DoP, Article 7 of the Regulation (EU) No 305/2011 (CPR) and the Commission Delegated Regulation (EU) No 157/2014 on the conditions for making a declaration of performance on construction products available on a website apply.

The information referred to in Article 31 or, as the case may be, in Article 33 of EC Regulation 1907/2006, (REACH) shall be provided together with the DoP.
