#### 1 Modifications to the Scope

Replace fourth paragraph except Note 102 and Note 103 with the following:

This standard deals with the reasonably foreseeable hazards presented by appliances that are encountered by all persons in and around the installation place. However, in general, it does not take into account:

- children playing with the appliance;
- the use of the appliance by very young children;

It is recognized that very vulnerable people may have needs beyond the level addressed in this standard.

# Relationship between this European Standard and the safety objectives of Directive 2014/35/EU [2014 OJ L96] aimed to be covered

This European Standard has been prepared under a Commission's standardization request relating to harmonized standards in the field of the Low Voltage Directive, M/511, to provide one voluntary means of conforming to safety objectives of Directive 2014/35/EU of the European Parliament and of the Council of 26 February 2014 on the harmonization of the laws of the Member States relating to the making available on the market of electrical equipment designed for use within certain voltage limits [2014 OJ L96].

Once this standard is cited in the Official Journal of the European Union under that Directive, compliance with the normative clauses of this standard given in Table ZZA.1 confers, within the limits of the scope of this standard, a presumption of conformity with the corresponding safety objectives of that Directive, and associated EFTA regulations.

Compliance with this Part 2 when used together with the Part 1 provides one means of conformity with the safety objectives.
