Standard Specification for Mineral Filler For Bituminous Paving Mixtures¹

This standard is issued under the fixed designation D 242/D 242M; the number immediately following the designation indicates the year of original adoption or, in the case of revision, the year of last revision. A number in parentheses indicates the year of last reapproval. A superscript epsilon (\$\varepsilon\$) indicates an editorial change since the last revision or reapproval.

This standard has been approved for use by agencies of the Department of Defense.

1. Scope

- 1.1 This specification covers mineral filler added as a separate ingredient for use in bituminous paving mixtures.
- 1.2The values stated in SI units are to be regarded as the standard. Inch-pound units, shown in parentheses, are for information only.
- 1.2 The values stated in either SI units or inch-pound units are to be regarded separately as standard. The values stated in each system may not be exact equivalents; therefore, each system shall be used independently of the other. Combining values from the two systems may result in non-conformance with the standard.
- 1.3 The text of this standard references notes and footnotes which provide explanatory material. These notes and footnotes (excluding those in tables and figures) shall not be considered as requirements of the standard.

3. General Description

3.1 Mineral filler shall consist of finely divided mineral matter such as rock dust, slag dust, hydrated lime, hydraulic cement, fly ash, loess, or other suitable mineral matter. At the time of use, it shall be sufficiently dry to flow freely and essentially free from agglomerations.

4.1 Mineral filler shall be graded within the following limits:

Sieve	Percent Passing (by Mass)
1.18 mm (No. 16)	100
1.18 mm [No. 16]	100
600-μm (No. 30)	97 to 100
600-μm [No. 30]	97 to 100
300-μm (No. 50)	95 to 100
300-μm [No. 50]	95 to 100
75-µm (No. 200)	70 to 100
75-μm [No. 200]	70 to 100

4.2 Mineral Filler prepared from rock dust, slag dust, loess, and similar materials shall be essentially free from organic impurities and have a plasticity index not greater than 4.

Note 1—Plasticity index limits are not appropriate for hydrated lime and hydraulic cement.
