Introduction

This document is based on the Code of Practice of the International Council of Tanners (ICT) – Code of Practice on the appropriate designation of leather used in upholstery (Hong Kong, 30 March 2009).

In the absence of national regulations this document provides the furniture industries with a standard on which to base their commercial communications to customers and the general public when leather is used in their products.

1 Scope

This document specifies requirements for the designations and descriptions in public or commercial communications, labels or product descriptions when leather is used in upholstered furniture and seating.

The designation or description of leather in footwear, leather goods and leather clothing including gloves are not covered by this document.

The designation and description of leather in automotive interior applications is covered in prEN 16223-2.

independent piece of upholstered furniture intended for seating purposes comprising contact and noncontact areas

3.2

upholstered furniture

furniture intended for sitting purposes comprising a frame, cushioning material and a covering, excluding loose cushions and free coverings, unless they are an integral part of the furniture

3.3

contact area

area of upholstered furniture or seating, that comes into contact with the body including the horizontal seat cover, arm rests, vertical seat back, and head/neck rest

3.4

non-contact area

area of upholstered furniture or seating, that is not intended for sitting purposes including areas on the outsides, backs and underside

3.5

underside

floor facing side of the furniture, covered or not

3.6

visible surface areas

total of contact area and non-contact area, excluding the underside
