Add the following reference:

EN 1730:2012, Furniture – Tables – Test methods for the determination of stability, strength and durability

2 Modification to Clause 3 "Terms and definitions"

Delete the definition

3.3

foldable mattress base

mattress base specifically designed to be folded for ease of storage, when not in use

Add a definition

3.3

woven fabric

fabric produced by interlacing (by weaving on a loom or weaving machine) a set of warp threads and a set of weft threads normally at right angles to each other (EN ISO 12947-2:2016 source ISO 3572:1976, 2.1)

3 Modification to Clause 5.1 "Measuring table"

Modify the clause to read:

iTeh STANDARD PREVIEW

A horizontal, flat and smooth surface with dimensions sufficient to fully support the mattress in any measuring position. The maximum deflection shall not exceed 1 mm when a force of 1000N is applied to the table when tested in accordance with EN 1730 cl 6.3.

In the last sentence, delete « but using the square tube specified in Subclause 5.3 of this standard »

5 Modification to Clause 8.2.1 "Labels and decals"

Change the title to read:

8.2.1 Glued labels and decals

6 Modification to Clause 8.2.1.1 "Requirements"

Replace the first sentence by:

When tested in accordance with 8.2.1.2, glued labels and decals having an area greater than 100 mm by 100 mm shall not become detached or be loosened from the product.

7 Modification to Clause 8.3.2.3.1 "Slippage of threads of mattress covers made of woven fabrics"

Add at the beginning of the clause:

Decorative stitches and quilting stitches are excluded from this requirement.

8 Modifications to Clause 8.3.2.3.2 "Tensile strength test for covers made of other materials"

Add at the beginning of the clause:

Decorative stitches and quilting stitches are excluded from this requirement.

Add a note at the end of the paragraph

NOTE Other materials are e.g.: knitted fabrics, cup pile fabric, uncut pile fabric, raised fabric, flocked fabric, rubber or plastic coated fabrics, non woven fabrics.

9 Modifications to Clause 8.5.2.2 "Test method"

Modify the 4th para as follows:

Apply the test force for 10 000 cycles at each point B and C, see 4.2.

10 Modifications to Clause 9.1 "Marking"

2nd para, replace the sentence

"The following markings are not applicable if the mattress is an integral part of the cot" by

"Additional markings for mattresses sold as standalone"

Add in e)

13 Modification to Clause A.4.4 "Suffocation hazards"

Replace the 2nd para by

The requirements in 8.2.1 are intended to cover the hazards associated with glued labels and plastic decals.

The hazards from impermeable layers of the mattress that can cover both the mouth and nose are addressed by the firmness test (8.2.3).
