“In transport applications, valves and fittings directly connect to the shell (including the internal stop-valve and its seating) shall be protected ~~in accordance with section 4.1.6.8 of the ADR.~~

“In transport applications, valves and fittings directly connect to the shell (including the internal stop-valve and its seating) shall be protected against the danger of being wrenched off by external stresses.”

Delete the NOTE:

“NOTE To provide valve protection on transportable containers.”
