- 29 household environment that may also be used by non-expert users for typical housekeeping functions:
- 30 in shops and other similar working environments;
- 31 in farm houses:
- 32 by clients in hotels, motels and other residential type environments;
- 33 in bed and breakfast type environments.
- NOTE Z102 Household environments include the dwelling and its associated buildings, the garden, etc.
- 35 As far as is practicable, this document deals with the common hazards presented by appliances that are
- 36 encountered by all persons in household and similar environments.
- 37 However, in general, it does not take into account
- 38 **children** playing with the appliance,
- 39 the use of the appliance by **very young children**,
- 40 the use of the appliance by young children without supervision,
- 41 **user maintenance** by **children**, including the cleaning of the appliance.
- 42 It is recognized that **very vulnerable people** may have needs beyond the level addressed in this document.
- 44 Add the following dashed items to Note 104:
- 45 tumble dryers to be used in commercial areas, e.g. laundrettes (see EN 50570);
