## Introduction

In respect of potential adverse effects on the quality of water intended for human consumption, caused by the product covered by this Standard :

- 1) This Standard provides no information as to whether the product may be used without restriction in any of the Member States of the EU or EFTA ;
- 2) It should be noted that, while awaiting the adoption of verifiable European criteria, existing national regulations concerning the use and/or the characteristics of this product remain in force.

## 1 Scope

This European Standard describes the characteristics and specifies the requirements and the corresponding test methods for trisodium orthophosphate used for treatment of water intended for human consumption. It gives information on its use in water treatment.

## 3.2 Commercial form

Trisodium orthophosphate is available in a number of different forms (see 3.3.1).

Different commercial forms, solids or dissolved in water are possible. All concentrations mentioned refer to the active matter and shall be calculated accordingly.

NOTE : Trisodium orthophosphate can be a component of mixtures sold for water treatment purposes.

## 3.4 Chemical properties

Solutions of trisodium orthophosphate have alkaline reactions.

The pH value of a solution containing 1 % (*m/m*) is approximately 12.

## 4 Purity criteria

Limits have been given for impurities and toxic substances where these are likely to be present in significant quantities from the current production process and raw materials. If a change in the production process or raw materials leads to significant quantities of other impurities or by-products being present, this shall be notified to the user.

### 4.1 Composition of commercial product

The product shall conform to the following requirements on a dry mass basis :

- phosphate content expressed as  $P_2O_5$  :  $(41 \pm 1,0)$  percent by mass (% (*m/m*)) ;
- sodium content expressed as  $Na_2O$  :  $(53 \pm 1,0)$  percent by mass (% (*m/m*)).

### 4.2 Impurities and main by-products

The product shall conform to the requirements specified in table 1.
