Part 15: Filter

1 Scope

This document specifies tests and requirements for the filter, a compressed gaseous hydrogen (CGH₂) and hydrogen/natural gas blend fuel system component intended for use on the types of motor vehicles defined in ISO 3833.

It is applicable to vehicles using CGH₂ in accordance with ISO 14687-1 or ISO 14687-2 and hydrogen/natural gas blend using natural gas in accordance with ISO 15403-1 and ISO/TR 15403-2. It is not applicable to the following:

- a) liquefied hydrogen (LH₂) fuel system components;
- b) fuel containers;
- c) stationary gas engines;

- e) electronic fuel management; [8fle4517e759/iso-12619-15-2017](https://standards.iteh.ai/catalog/standards/sist/eab315b2-d66c-4521-9402-8fle4517e759/iso-12619-15-2017)
- f) refuelling receptacles;
- g) fuel cell vehicles.

NOTE 1 It is recognized that miscellaneous components not specifically covered herein can be examined to meet the criteria of this document and tested according to the appropriate functional tests.

NOTE 2 All references to pressure in this document are considered gauge pressures unless otherwise specified.

4 Marking

Marking of the component shall provide sufficient information to allow the following to be traced:

- a) the manufacturer's or agent's name, trademark or symbol;
- b) the model designation (part number);
- c) the temperature range.

The following additional markings are recommended:

- the direction of flow (when necessary for correct installation);
- the type of fuel;
- the electrical ratings (if applicable);
- the symbol of the certification agency;
- the type approval number;
- the serial number or date code;
- a reference to this document, i.e. ISO 12619-15:2017.

NOTE This information can be provided by a suitable identification code on at least one part of the component when it consists of more than one part.

5 Construction and assembly

The filter shall comply with the applicable provisions of ISO 12619-1 and ISO 12619-2 and with the tests specified in [Clause 6](#). Tolerances should follow the specifications of ISO 12619-2.

If non-conductive materials are used, the filter shall be designed to take its conductivity into account.

6 Tests

6.1 Applicability

The tests required to be carried out are indicated in [Table 1](#).

6.2 Hydrostatic strength

Test the filter according to the procedure for testing hydrostatic strength specified in ISO 12619-2. The test pressure shall be 2,5 times the working pressure.

6.3 Continued operation

Test the filter in accordance with the procedure for testing continued operation given in ISO 12619-2 for a total of 20 00 cycles.

Following cycling testing, perform the hydrostatic strength test in accordance with 6.2.

6.4 Vibration resistance

Vibrate the filter, pressurized to its working pressure and sealed at both ends, for 30 min along each of the three orthogonal axes at the most severe resonant frequencies determined as follows:

- by an acceleration of 1,5 g;
- within a sinusoidal frequency range of 10 Hz to 500 Hz;
- with a sweep time of 10 min.

If the resonance frequency is not found in this range, the test shall be conducted at 500 Hz.

At the completion of the test, the filter shall not show any indication of fatigue or component damage and shall meet the leakage test requirements as specified in ISO 12619-2:2014, Clause 6. Following the leakage testing, perform the hydrostatic strength test in accordance with 6.2.
