#### 1 Scope

This document specifies a general method of test for determining the mass fraction in percent of matter volatile at a temperature of 105 °C in a sample of pigment or extender.

This method is applicable to pigments and extenders that are stable at 105  $^{\circ}\text{C}$ .

#### 4 Apparatus

- **6.1 Weighing bottle**, squat form, wide-mouthed, with ground glass topper.
- **6.2 Oven**, capable of maintaining the temperature at  $(105 \pm 2)$  °C.
- **6.3 Balance**, accurate to 0,1 mg.
- **6.4 Desiccator**, containing an efficient desiccant.

#### 5 Sampling

Take a representative sample of the product under test, in accordance with ISO 15528.
