## FOREWORD

### 3 Terms and definitions

*Add the following new definitions:*

#### 3.105

##### **washable clipper**

clipper, the hand-held part of which can be cleaned under water

#### 3.106

##### **wet clipper**

clipper, the hand-held part of which may be used in a bath or shower

#### 3.107

##### **washable epilator**

epilator, the hand-held part of which can be cleaned under water

#### 3.108

##### **wet epilator**

epilator, the hand-held part of which may be used in a bath or shower

## 6 Classification

**6.1** *Replace the second paragraph of the modification by the following:*

**Washable shavers, wet shavers, washable clippers, wet clippers, washable epilators and wet epilators shall be class II or class III.**

**6.2** *Replace the first sentence of the addition by the following:*

**Washable shavers, wet shavers, washable clippers, wet clippers, washable epilators and wet epilators** shall be at least IPX7.

## 7 Marking and instructions

**7.1** *In the first paragraph of the addition, replace **washable shavers** by **washable shavers, washable clippers,** and **washable epilators.***

and wet epilators.

**7.12** *In the penultimate paragraph of the addition, replace “for shavers” by “for appliances” and replace “washable shavers or wet shavers” by “washable shavers, wet shavers, washable clippers, wet clippers, washable epilators or wet epilators”.*

*In the last paragraph of the addition, replace “washable shavers” by “washable shavers, washable clippers, and washable epilators.”*

**7.12.1** Replace the text of the addition by the following:

**washable epilators** and **wet epilators**, other than those classified IPX7, shall state that the parts that have to be fixed must be installed so they cannot fall into water.

## 11 Heating

11.8 Replace the first sentence of the addition by the following:

*The temperature rise of parts that are in contact with skin in normal use, or are held in the hand, shall not exceed the limits specified for handles which are continuously held in normal use. The temperature rise of parts of hair clippers or trimmers that are in contact with hair in normal use, and may contact the skin for short periods, shall not exceed the limits specified for handles which in normal use are held for short periods only.*

## 20 Stability and mechanical hazards

*Replace the text by the following:*

This clause of Part 1 is applicable except as follows.

### 20.1 Replacement:

Appliances, other than **fixed appliances** and **hand-held appliances** without a charging stand, intended to be used on a surface such as the floor or a table, shall have adequate stability.
