## Relationship between this European Standard and the safety objectives of Directive 2014/35/EU [2014 OJ L96] aimed to be covered

This European Standard has been prepared under a Commission's standardization request relating to harmonized standards in the field of the Low Voltage Directive, M/511, to provide one voluntary means of conforming to safety objectives of Directive 2014/35/EU of the European Parliament and of the Council of 26 February 2014 on the harmonization of the laws of the Member States relating to the making available on the market of electrical equipment designed for use within certain voltage limits [2014 OJ L96].

Once this standard is cited in the Official Journal of the European Union under that Directive, compliance with the normative clauses of this standard given in Table ZZA.1 confers, within the limits of the scope of this standard, a presumption of conformity with the corresponding safety objectives of that Directive, and associated EFTA regulations.

Compliance with this Part 2 when used together with the Part 1 provides one means of conformity with the safety objectives.

#### 5 General conditions for the tests

**5.7** Replace the entire text of the modification by the following:

For **controlled blankets** and **mattresses**, the tests of Clauses 10, 11 and 19 are carried out at an ambient temperature 15  $^{\circ}$ C  $\pm$  5  $^{\circ}$ C.

#### 7 Marking and instructions

**7.1** Add the following to the first paragraph of the modification:

If the appliance has two means of connection to the supply, the **rated power input** shall be stated for each circuit separately and the information provided on a single label.

The **rated power input** may be expressed as 2 x **rated power input** for each circuit in watts. Other ways of expressing the **rated power input** may be used and the total given, provided they do not give rise to misunderstanding.
