FOREWORD

Part 2-28: Tests – Industrial atmosphere (sulphur dioxide)

1 General

1.1 Scope and object

The purpose of this part of IEC 1300 is to assess the corrosive effects of atmospheres polluted with sulphur dioxide on fibre optic devices. The procedure is only suitable for comparative purposes. It can be considered a general corrosion test which may not predict the behaviour of the devices in use.

1.2 General description

This procedure is conducted in accordance with IEC 68-2-42, test Kc. The specimen is exposed to the sulphur dioxide for a specified period of time.

2 Apparatus

The apparatus consists of a test chamber in accordance with IEC 68-2-42, test Kc.

3 Procedure

3.1 Conditioning

Conduct the test in accordance with IEC 68-2-42, test Kc. The preparation of the specimen shall be in accordance with the detail specification. Unless otherwise specified, the specimen shall be subjected to the test in a non-operational mode.
