**1 Modification to Clause 2, “Normative references”****Replace**

“IEC 60695-11-5:2004, *Fire hazard testing - Part 11-5: Test flames - Needle-flame test method - Apparatus, confirmatory test arrangement and guidance*”

with

“IEC 60695-11-5:2016, *Fire hazard testing - Part 11-5: Test flames - Needle-flame test method - Apparatus, confirmatory test arrangement and guidance*”

**2 Modification to Clause 10, “Mechanical properties”**

In 10.2.101 **replace** the fourth paragraph with

“Within the width of the sample:

- for trunking with a width less than 62,5 mm, one fixing is used as shown in Figure 103 a)
- for trunking with a width equal or greater than 62,5 mm, two fixings are used as shown in Figure 103 b).”

and **replace** in the sixth paragraph “class 5, Table 3” with “Table 3 - class 5”.

**3 Modification to Clause 13, “Fire hazard”**

In 13.1.3, last paragraph, **replace** “IEC 60695-11-5:2004” with “IEC 60695-11-5:2016”.

**4 Modification to Figure 103, “Fixing distances for cable support test”**

In “Figure 103 – Fixing distances for cable support test”

**replace** the title of Figure 103 a) with

“a) Fixing distances for cable support test for trunking with a width less than 62,5 mm”

**replace** the title of Figure 103 b) with

“b) Fixing distances for cable support test for trunking with a width equal or greater than 62,5 mm”

**5 Modification to Annex B, “CTS/CDS IK code”**
