20.101 *Replace the requirement by the following:*

Appliances shall be operated by a switch constructed so that inadvertent operation is unlikely or they shall be operated by a switch that automatically returns to the **off-position** when its actuating member is released.

22 Construction

22.102 *Replace the last sentence of the first paragraph of the requirement by the following:*

Except for steam cleaners intended exclusively for floor cleaning, steam emission shall stop when the switch actuator is released.
