Replace the first sentence of A.5 with the following:

"The test methods for measuring whole-body vibration and hand-arm vibration shall be in accordance with ISO 2631-1 and ISO 5349-1 respectively, taking in account that vibration absorbed by the torso of the operator on pedestrian-controlled machines is not measured effectively by these standards."
