1 Scope

This document specifies fuse-links with tabs (blade-type) Type P (sub miniature three tabs) for use in road vehicles. It establishes, for this fuse-link type, the rated current, test procedures, performance requirements and dimensions.

This document is applicable for fuse-links with a rated voltage of 32 V a current rating of \leq 30 A and a breaking capacity of 1 000 A intended for use in road vehicles.

This document is intended to be used in conjunction with ISO 8820-1 and with ISO 8820-2. The numbering of its clauses corresponds to that of ISO 8820-1 whose requirements are applicable, except where modified by requirements particular to this document.

5 Tests and requirements

5.1 General

5.1.1 Test criteria

In addition to carrying out the test procedures in accordance with ISO 8820-1, the following criteria apply.

Tests shall be performed following the test sequences in <u>Table 2</u>.

The test fixtures for electrical tests shall be designed in accordance with Figure 1. Only one element at a time is energized. The connection resistance shall be $\leq 0.8~\text{m}\Omega$ for Type P fuse-links to ensure the proper function of the test fixture. Each electrical test shall be repeated after a fuse-link is repositioned in the fixture shown in Figure 1.

Fuse-links according to this document shall provide for visible evidence of an open fuse-element.
