European foreword

This document (prEN 12934:2024) has been prepared by Technical Committee CEN/TC 443 "Feather and down", the secretariat of which is held by UNI.

This document is currently submitted to the CEN Enquiry.

This document will supersede EN 12934:1999.

prEN 12934:2024 includes the following significant technical changes with respect to EN 12934:1999:

- Clause 3 has been improved with new definitions;
- Clause 5 has been modified (removed sub clauses 5.4 to 5.6, and Table 1 has been modified);
- Clause 6 has been modified (text has been added and Table 2 has been modified);
- Table 4 has been modified;
- A new Clause 8 has been added and the following clauses have been renumbered.

Introduction

Before 1999, fillings of feather and down were covered by different, sometimes conflicting, standards in the various CEN countries. These national standards were replaced by EN 12934:1999, which provided uniform labelling of down and feather products in all CEN countries.

Because of changing market conditions, changing down and feather processing methods, and changing consumer and retailer demands, revisions to EN 12934 were necessary.

The revised EN 12934 meets the needs of these changes with the same goals as the original version of EN 12934, to provide unambiguous labelling in terms of:

- denominations of the components of plumage and of fowl species;
- information to be stated on product labels and in commercial documents within the supply chain with reference to plumage and plumage-filled finished products;
- assessment of whether test results indicate conformity to labelling requirements based upon a stipulated tolerance.
