1 Modification to the Introduction

Addition:

This European amendment A11 supplements or modifies the corresponding clauses of the standards below:

- EN 60335-1:2012+A11:2014+A13:2017+A1:2019+A14:2019+A2:2019+A15:2021+A16:—¹ (Part 1)
- EN IEC 60335-2-115:2023 (Part 2)

2 Modification to Clause 1, "Scope"

Replace the fourth paragraph, except Note 103, starting with "This standard deals with the common hazards presented by appliances." by the following:

This document deals with the reasonably foreseeable hazards presented by appliances that are encountered by all persons. However, in general, it does not take into account:

- children playing with the appliance;
- the use of the appliance by **children**;

It is recognized that **very vulnerable people** can have needs beyond the level addressed in this document.

Addition:

This document does not deal with any specific requirements on noise emitted from the appliance as the generated noise is not considered to be a relevant hazard.

3 Modification to Clause 3, "Terms and definitions"

Delete subclause 3.5.102.

4 Modification to Clause 7, "Marking and instructions" bdb1-2311-4a80-8925-

7.12 Modification

Replace the third paragraph of Part 1 starting with "This appliance can be used by children aged from 8 years..." by the following:

This appliance shall not be used by **children**. Cleaning and **user maintenance** shall not be made by **children**. Appliances can be used by persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and if they understand the hazards involved. **Children** shall not play with the appliance.

Always disconnect the appliance from the supply before assembling, disassembling or cleaning.

5 Modification to Clause 22, "Construction"

Delete subclause 22.102.

22.107 Modification

Replace the first dashed item of the 1st paragraph by the following:

suction pressure does not damage human skin;

Add a new sentence before the first paragraph in the compliance criteria starting with "For appliances that can produce a vacuum pressure exceeding 75kPa, ...":

Appliance with suction pressure not exceeding 75kPa is considered to be safe for human skin.

Delete subclause 26.101.

7 Modification to annexes

Annex ZE (normative)

Specific additional requirements for appliances and machines intended for commercial use

This annex of Part 1 is applicable except as follows:

1 Scope

Replace the addition in Part 1 by the following:

This annex deals with additional requirements concerning appliances and machines with power driven parts intended to be used by experts or trained users for example in shops, beauty parlors, etc. and appliances and machines with power driven parts which are declared to be for commercial use by lay persons.

The statement from the manufacturer in the product information concerning the specific product is the criterion that has to be considered to determine the intended use of the appliance. The statement shall accurately reflect the reasonably foreseeable use of the product.

Products covered by this document do not create a noise hazard, therefore no specific provisions concerning noise are given.

7 Marking and Instructions

Add the new following subclauses:

7.12.Z101

The instructions shall contain the following:

the A-weighted emission sound pressure level is below 70 dB(A);

8 Protection against access to live parts

8.1.1 Addition

Test probe 18 is not applied to appliances used only in beauty parlors and similar premises.

19 Abnormal operation

This clause of Annex ZE of Part 1 does not apply.

20 Stability and mechanical hazards

20.2 Addition

Test probe 18 is not applied to appliances used only in beauty parlors and similar premises.

22 Construction

22.ZE.6 Replace the third paragraph by the following:

The **guard** is opened to the extend needed to cause the interlocking to operate and is then closed. This operation is carried out for 5000 cycles at a rate of 5 cycles per minute.
