Proper cleaning is essential to keep the reusable shipping packaging material clean and hygienic during the time of intended use. The cleaning and hygienic sanitation procedures for reusable transport items described in this document can be used by all stakeholders (e.g. suppliers, emptiers, packers and fillers) involved in the reusable container loop system.
