2 Definitions

Add, on page 11, the following new definition:

2.2.103 **installation wall**: A special fixed construction containing supply facilities for appliances installed in conjunction with it.

Page 11

4 General conditions for the tests

Add the following text:

4.10 Addition:

*Appliances intended for installation in a bank of other appliances and appliances intended to be fixed to an **installation wall** are enclosed to obtain protection against electric shock and harmful ingress of water equivalent to that obtained when installed in accordance with the instructions provided with the appliance.*

NOTE – Appropriate enclosures or additional appliances may be needed for test purposes.

Page 13

7 Marking and instructions

7.12.1 *Add, on page 15, the following text after the first sentence of the replacement:*

For appliances intended for installation in a bank of other appliances and appliances intended to be fixed to an **installation wall**, details of how to ensure appropriate protection against electric shock and harmful ingress of water shall be supplied. If the controls of more than one appliance are combined in a separate enclosure, detailed installation instructions shall be supplied.
