 - latest date by which the existence of this (doa) dor + 6 months document has to be announced at national level
 - latest date by which this document has to be (dop) dor + 12 months implemented at national level by publication of an identical national standard or by endorsement
 - latest date by which the national standards (dow) dor + 48 months
 conflicting with this document have to be
 withdrawn (to be confirmed or
 modified when voting)

- 20 This series is divided into four parts: 11eh Standards
- 21 Part 1: General requirements which are common to most hand-held electric motor operated tools (for the
- 22 purpose of this document referred to simply as tools) which could come within the scope of this document;
- 23 Part 2, 3 or 4: Requirements for particular types of tools which either supplement or modify the requirements
- 24 given in Part 1 to account for the particular hazards and characteristics of these specific tools.
- 25 The Part 4-4 is used in conjunction with EN 62841-1:2015 + A11:2022.
- 26 The Part 4-4 supplements or modifies the corresponding clauses in EN 62841-1:2015 + A11:2022, so as to
- 27 convert it into the European Standard: Particular requirements for lawn trimmers, lawn edge trimmers, grass
- 28 trimmers, brush cutters and brush saws.
- Where a particular subclause of Part 1 is not mentioned in Part 4-4, that subclause applies as far as relevant.
- When this document states "addition", "modification" or "replacement", the relevant text in Part 1 is to be adapted
- 31 accordingly.

- 35 notes: in smaller roman type.
- 36 The terms defined in Clause 3 are printed in **bold typeface**.

- 42 Commission. The Standing Committee of the EFTA States subsequently approves these requests for its
