This draft amendment prAB, if approved, will modify the European Standard EN IEC 60335-2-25:2021; it is submitted to CENELEC members for enquiry. Deadline for CENELEC: 2023-06-30.

It has been drawn up by CLC/TC 61.

If this draft becomes an amendment, CENELEC members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for giving this amendment the status of a national standard without any alteration.

This draft amendment was established by CENELEC in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CENELEC member into its own language and notified to the CEN-CENELEC Management Centre has the same status as the official versions.

This document (EN IEC 60335-2-25:2021/prAB:2023) has been prepared by CLC/TC 61 "Safety of household and similar electrical appliances".

This document is currently submitted to the Enquiry.

The following dates are proposed:

- latest date by which the existence of this (doa) dor + 6 months document has to be announced at national level
- latest date by which this document has to be (dop) dor + 12 months implemented at national level by publication of an identical national standard or by endorsement
- latest date by which the national standards (dow) dor + 36 months conflicting with this document have to be (to be confirmed or withdrawn modified when voting)

The numbering system for European clauses, subclasses, notes, tables, figures and annexes that are additional to those in the IEC standard are prefixed with the letter "Z".

This document has been prepared under a Standardization Request given to CENELEC by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s) / Regulation(s).

For relationship with EU Directive(s) / Regulation(s), see informative Annex ZZA, which is an integral part of EN IEC 60335-2-25:2021/A11:2021.

Rational Issue manager:

This proposal is referring to EN 60335-1:2012+A11:2014+ A13:2017+A1:2019+A14:2019+A2:2019+A15: 2021+FprA16:2021 and EN IEC 60335-2-25: 2021+A11:2021.

It covers the DE NC and GB NC technical comments from formal vote result CLC/TC 61(SEC) 2673B. DK NC comment is not considered in this proposal as it is part of next edition 8 of IEC 60335-2-25 project. It is suggested to postpone this modification till the adoption of IEC 60335-2-25 edition 8(under CDV stage and forecast publication 2023).

1 Modification to the Introduction

Addition:

This European amendment A12 supplements or modifies the corresponding clauses of the standards below:

- EN 60335-1:2012+A11:2014+A13:2017+A1:2019+A14:2019+A2:2019+A15:2021+A16:2023 (Part 1)
- EN IEC 60335-2-25:2021+A11:2021 (Part 2)

2 Modification to the Scope

Add the following before the fifth paragraph starting from "As far as is practicable,....":

Appliances not intended for normal household use but which nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in shops, in light industry and on farms, are within the scope of this document. However, if the appliance is intended to be used professionally to process food for commercial purposes, the appliance is not considered to be for household and similar use only.

3 Modification to Clause 7, " Marking and instructions"

7.1 Addition:

When the provisions of footnote a to Table Z101 apply, the appliance shall be marked with:

- the substance of "CAUTION: Hot surface"; or
- symbol IEC 60417-5041.
- 7.6 Addition:

[symbol IEC 60417-5041] Caution, hot surface

7.14 Addition:

The height of the warning "CAUTION. Hot surface" shall be at least 4 mm (measured on the capital letters).

NOTE Z101For the evaluation of legibility and clarity of safety warnings guidance can be found on EN IEC/IEEE 82079-1:2020.

The height of the symbol IEC 60417-5041:2002 shall be at least 12 mm.

7.15 Addition:

If the hot surface marking in 7.1, or symbol IEC 60417-5041 (2002-10) is marked on the appliance, it shall be visible when the appliance is operated as in **normal use**, including when actuating any switch, adjusting any control or opening a lid or door. It shall not be placed on a **functional surface** or **adjacent surface**.

During the test, the temperature rises are monitored continuously and shall not exceed the values shown in Table 3 and Table Z101.

In Table 3 of Part 1, add the following to footnote k:

^k - Similar parts held for short periods include handles or grips of vents and air shutters.

In Table Z101, footnote a, replace the wording "When, for appliance covered by Annex AA," *by the following:* "When the required values are not met,"
