This draft amendment prAB, if approved, will modify the European Standard EN IEC 60335-2-84:2021; it is submitted to CENELEC members for enquiry.

Deadline for CENELEC: 2023-06-30.

It has been drawn up by CLC/TC 61.

If this draft becomes an amendment, CENELEC members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for giving this amendment the status of a national standard without any alteration.

This draft amendment was established by CENELEC in three official versions (English, French, German).

- latest date by which the existence of this document has to be announced at national level (doa) dor + 6 months
- latest date by which this document has to be implemented at national level by publication of an identical national standard or by endorsement (dop) dor + 12 months
- latest date by which the national standards conflicting with this document have to be withdrawn (dow) dor + 36 months (to be confirmed or modified when voting)

The numbering system for European clauses, subclauses, notes, tables, figures and annexes that are additional to those in the IEC standard are prefixed with the letter "Z".

This document has been prepared under a Standardization Request given to CENELEC by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s) / Regulation(s).

During the plenary meeting of October 2022 we decide as follow (See SEC 2699 item 40):

IM shall prepare a draft for incorporating the test probe 19 in the standard.

Consequentially, the draft has been prepared for reflecting the decision taken in plenary meeting.

Addition:

This European amendment A12 supplements or modifies the corresponding clauses of the standards below:

- EN IEC 60335-2-84:2021+A11:2021 (Part 2)

2 Modification to the Scope

In the replacement of European Common modification, replace the following dashed item “the use of the appliance by very young children without supervision” by:

- the use of the appliance by **very young children** without constant observation;

3.6.3 Modification:

Replace “test probe B and probe 18” by “test probe B, test probe 18 and test probe 19”.

4 Modification to Clause 7 “Marking and instructions”

7.12 Replace in the standard EN IEC 60335-2-84:2021/A11, the first modification starting with “In the fourth paragraph of Part 1,…” as follow:

In Part 1, replace the text of the fourth paragraph starting with “This appliance can be used…” up to “... children without supervision” by the following:

This appliance can be used by **Children** below 3 years but require constant observation by an adult in the immediate proximity of the child. This appliance can be used by **children** aged from 3 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. **Children** shall not play with the appliance. Cleaning and user maintenance shall not be made by children without supervision.
