Amendment to include the following:

2.7 Filled glass paper

Paper in which at least 65 % of the raw material composition is glass fibres and inorganic fillers (such as silicates of aluminium) with or without the addition of other fibres and/or binder materials.

2.8 Hybrid inorganic/organic paper

Paper made with organic fibres, such as polyethylene terephthalate fibres, and inorganic fillers (such as silicates of aluminium) with or without the addition of other fibres and/or binder materials.
