The main changes compared to the previous editions are as follows:

- combination of ISO 15087-1, ISO 15087-2, ISO 15087-3, ISO 15087-4, ISO 15087-5 and ISO 15087-6 in one document;
- harmonization with ISO 4865-1;
- requirement for reprocessing has been added in [5.7](#);
- requirement for UDI code has been added in [Clause 7](#);
- deletion of Annex A (Measurement of dimensions) from ISO 15087-1;
- deletion of Annex B (Vickers hardness testing) from ISO 15087-1,
- deletion of Annex C (Test under tensile load), from ISO 15087-1;
- deletion of Annex D (Test under torque) from ISO 15087-1.
