The main changes are as follows:

- requirements and test methods have been referenced from ISO 4865-1:2023, *Dentistry — General requirements of hand instruments — Part 1: Non-hinged hand instruments*
- overall lengths have been reduced from 178 mm to 173 mm;
- new figure has been added in Type 1 classification
- marking, labelling, and packaging have been referenced from ISO 4865-1:2023, *Dentistry – General requirements of hand instruments – part 1: Non-hinged hand instruments* in Clause 7
