## Part 4: Manual valve

### 1 Scope

This document specifies tests and requirements for the manual valve, a liquefied natural gas fuel system component intended for use on the types of motor vehicles defined in ISO 3833. This document is not applicable to the following:

- a) fuel containers;
- b) stationary gas engines;
- c) container mounting hardware;
- d) electronic fuel management;
- e) refuelling receptacles.

It is recognized that miscellaneous components not specifically covered herein can be examined to meet the criteria of this document and tested according to the appropriate functional tests.

All references to pressure in this document are to be considered gauge pressures unless otherwise specified.

This document is based upon a working pressure for natural gas as a fuel of 1,6 MPa (16 bar<sup>1</sup>). Other working pressures can be accommodated by adjusting the pressure by the appropriate factor (ratio). For example, a 2 MPa (20 bar) working pressure system will require pressures to be multiplied by 1,25.

## 4 Marking

Marking of the component shall provide sufficient information to allow the following to be traced:

- a) the manufacturer's or agent's name, trademark, or symbol;
- b) the model designation (part number);
- c) the working pressure or pressure and temperature range.

The following additional markings are recommended:

- i) the direction of flow (when necessary for correct installation);
- ii) the type of fuel;
- iii) the symbol of the certification agency;
- iv) the type approval number;
- v) the serial number or date code;
- vi) a reference to this document (i.e. ISO 12614-4).

NOTE This information can be provided by a suitable identification code on at least one part of the component when it consists of more than one part.

## 5 Construction and assembly

The manual valve shall comply with the applicable provisions of ISO 12614-1 and ISO 12614-2, and with the tests specified in [Clause 6](#).

### 6.1 Applicability

The tests required to be carried out are indicated in [Table 1](#).

## 6.2 Hydrostatic strength

Test the manual valve according to the procedure for testing hydrostatic strength specified in ISO 12614-2. The test pressure shall be 2,5 times the working pressure.

## 6.3 Leakage

Test the manual valve at the temperatures and pressures given in [Table 2](#).

## 6.4 Continued operation

**6.4.1** Test the manual valve in accordance with the procedure for testing continued operation given in ISO 12614-2, for 100 cycles, but lower the downstream pressure of the test fixture to less than 0,5 MPa (5 bar), and perform the leakage test in accordance with [6.3](#).

**6.4.2** Following cycling and leakage retesting, the manual valve shall be capable of completely opening and closing when a torque no greater than the appropriate one specified in [Table 3](#) is applied to the valve handle in a direction that opens it completely and in the opposite direction. The test shall be conducted with the valve pressurized at working pressure.

**6.4.3** Conduct the test at the appropriate maximum temperature according to ISO 12614-1:2021, 4.3.2 and 4.3.3, then repeat the test at a temperature of <-162 °C and with the appropriate maximum torque specified in [Table 4](#), below.
