prEN 12875-2:2024 (E)**Introduction**

This document specifies the conditions for visual inspection and evaluation of metallic and non-metallic utensils in connection with the standardized dishwashing resistance tests including the expression of results.

Further parts of EN 12875, under the general title *Mechanical dishwashing resistance of utensils* are as follows:

- *Part 1: Reference test method for domestic articles*
- *Part 4: Rapid test for domestic ceramic articles*
- *Part 5: Rapid test for ceramic catering articles*

NOTE The marking based on these test results is primarily intended as consumer information. In the opinion of consumers other features of equivalent importance exist which are not always compatible with high dishwashing resistance requirement.
