Introduction

For many companies, additive manufacturing represents an alternative to more conventional manufacturing processes such as casting, forging and milling. The trend towards complex components, decentralised production and customer specific products allows an economically feasible use for more and more areas. This also applies to many series applications, which comprise completely different demands on the efficiency of the processes.
