2 This document (prEN IEC 60335-2-17:2024/prAA:2024) has been prepared by CLC/TC 61 "Safety of
3 household and similar electrical appliances".

4 This document is currently submitted to the Enquiry.

5 The following dates are proposed:

- latest date by which the existence of this document has to be announced at national level (doa) dor + 6 months
- latest date by which this document has to be implemented at national level by publication of an identical national standard or by endorsement (dop) dor + 12 months
- latest date by which the national standards conflicting with this document have to be withdrawn (dow) dor + 36 months (to be confirmed or modified when voting)

14 **1 Modification to the Introduction**

15 *Addition:*

16 With European amendment A11, EN 60335-2-17:2013+A1:2020+A2:2021+A11:2019 is superseded.

17 This European amendment A11 supplements or modifies the corresponding clauses of the standards below:

- 18 — EN IEC 60335-1:2023+A11:2023 (Part 1)
- 19 — EN IEC 60335-2-17:2024 (Part 2)

20 **2 Modification to Clause 1, “Scope”**

21 *Replace the sixth paragraph starting with “As far as is practicable,...” up to “... in general, it does not take*
 22 *into account ” except for the dashed items with the following:*

23 “This standard deals with the reasonably foreseeable hazards presented by appliances and machines that are
 24 encountered by all persons. However, in general, it does not take into account:”

25 *Add before the sixth paragraph starting with “Attention is drawn to the fact” the following:*

26 “It is recognized that people with disabilities can have needs beyond the level addressed in this standard.”

27 **3 Modification to Clause 2, “Normative references”**

28 *Addition:*

29 EN IEC 60335-1:2023,¹ *Household and similar electrical appliances - Safety - Part 1: General requirements*

30 **4 Modification to Clause 7, “Markings and instructions”**

31 **7.12 Addition**

32 *In the eighth paragraph starting with “The instructions shall state the substance of the following”, add the*
 33 *following dashed items:*

34 “

35 — The appliance can be used by children older than 3 years and younger than 8 years under supervision
 36 and with the control always set to minimum temperature value

37 — If the appliance is equipped with **a remote operation** the instructions shall include the substance of the
 38 following warnings:

39 WARNING — disconnect the remote operation function before the appliance comes into contact with the
 40 user.

41 WARNING — appliances are not intended to be operated by means of an external timer or separate
 42 remote-control system.”

Secretary Note: the above sentence is in line with decision taken in document 61/6883A/INF. The above sentence is mandatory for addressing the ERs and link the standard to RED

43 *Delete the paragraph starting with “The instruction shall state that the appliance is not to be used by young*
 44 *children over the age of three unless...”.*

45 *Add the following after the last paragraph:*

46 “The cable and control unit of the appliance can give rise to risks of entanglement, strangulation, tripping or
47 treading if not correctly arranged. The user shall make sure that excess ties and electric cords shall be
48 arranged in a safe way.”

49 **7.12.1 Addition:**

50 “The instructions shall state that any repairs shall be carried out by competent persons.”

5 5 Modification to Clause 11, “Heating”

52 **11.101 Addition**

53 “For **remote operation** of appliances, the test is repeated with the control units and cord switches adjusted to
54 the highest setting and maximum duration of operation that can be set for **remote operation**.”

55 6 Modification to Clause 22, “Construction”

56 **22.40** *Replace the second paragraph and the NOTE with the following:*

57 “Appliances for **remote operation** shall be fitted with a switch for stopping the operation of the appliance. The
58 actuating member of this switch shall be easily visible and accessible.

59 *Compliance is checked by inspection.”*

Secretary Note: the above sentence is in line with decision taken in document 61/6883A/INF and proposal 61/6818/DC. The above sentence is mandatory for addressing the ERs and link the standard to RED

60 **22.49** *Replacement:*

61 “For **remote operation**, the duration of operation shall be set before the appliance can be started.

62 *Compliance is checked by inspection.”*

Secretary Note: the above sentence is in line with decision taken in document 61/6883A/INF and proposal 61/6818/DC. The above sentence is mandatory for addressing the ERs and link the standard to RED

63 **22.51** *Replacement:*

64 “A control on the appliance shall be manually adjusted to the setting for **remote operation** before the
65 appliance can be operated in this mode. There shall be a visual indication on the appliance showing that the
66 appliance is adjusted for **remote operation**.

67 *Compliance is checked by inspection.”*

68 7 Modification to Clause 31, “Resistance to rusting”

69 *Replace “This clause of Part 1 is applicable” with “This clause of Part 1 is not applicable”.*

70 8 Modification to the annexes

71 *At the end of the sentence starting with “The annexes of Part 1 are applicable” add “except as follows”.*
