 - latest date by which this document has to be (dop) dor + 12 months implemented at national level by publication of an identical national standard or by endorsement
 - latest date by which the national standards (dow) dor + 36 months conflicting with this document have to be withdrawn
 latest date by which the national standards (dow) dor + 36 months (to be confirmed or modified when voting)

- 16 With European amendment A11, EN 60335-2-13:2010+A11:2012+A1:2019 is superseded.
- 17 This European amendment A11 supplements or modifies the corresponding clauses of the standards below:
- 18 EN IEC 60335-1:2023+A11:2023 (Part 1)
- 19 EN IEC 60335-2-13:2024 (Part 2)

20 2 Modification to Clause 1, "Scope"

- 21 In the second paragraph starting with "Appliances intended for normal household...", remove the word
- 22 "normal".
- 23 After the second paragraph starting with "Appliances intended for normal household...", add the following:
- 24
- NOTE Z101Examples of appliance for household environment are appliances for typical housekeeping functions used in
- the household environment that may also be used by non-expert users for typical housekeeping functions:
- 27 in shops and other similar working environments;
- 28 in farm houses;
- 29 by clients in hotels, motels and other residential type environments;
- 30 in bed and breakfast type environments.
- 31 NOTE Z102Household environments include the dwelling and its associated buildings, the garden, etc."
- 32 Replace the fourth paragraph starting with " As far as is practicable,..." up to "... in general, it does not take
- into account " except for the dashed items with the following:
- 34 "This standard deals with the reasonably foreseeable hazards presented by appliances and machines that are
- 35 encountered by all persons. However, in general, it does not take into account:"
- 36 Add before the fifth paragraph starting with "Attention is drawn to the fact" the following:
- 37 "It is recognized that people with disabilities can have needs beyond the level addressed in this standard."

- 42 **7.1** Addition
- 43 At the end of the paragraph starting with "If appliances have external accessible surfaces...", add the
- 44 following:
- 45 "The warning shall be put on the surface of the appliance having the highest temperature and shall be visible
- 46 during **normal operation**."

- 48 In the fourth paragraph starting with "The instructions shall state the substance of the following", add the following dashed items:

- This appliance shall not be used by children from 0 year to 8 years. This appliance can be used by children aged from 8 years and above if they are continuously supervised. This appliance can be used by people with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. Keep the appliance and its cord out of reach of children aged less than 8 years. Cleaning and user maintenance shall not be made by children.
- 57 Cooking appliances should be positioned in a stable situation with the handles (if any) positioned to avoid spillage of the hot liquids."
- 59 **7.14** Replacement
- Replace the addition with the following:
- 61 "The height of symbol IEC 60417-5041(2002-10-07) shall be at least 8 mm.
- 62 The height of the warning "CAUTION. Hot surface" shall be at least 4 mm measured on the capital letters."
