1 Scope

This document specifies definitions of and general requirements to a pressure relief valve for limiting internal pressure of DME fuel containers intended for use on the types of motor vehicles as defined in ISO 3833. It also provides general design principles and specifies requirements for instructions and marking.

This document is applicable to vehicles using gaseous fuels in accordance with ISO 16861. It is not applicable to the following:

- a) a)–fuel containers for any application other than as noted above;
- b) b)-stationary, ship, railroad vehicle or aircraft DME engine installations;
- c) c)-fuel container mounting hardware; Stand are the set of the
- d) d) parts of vehicle fuel systems other than the fuel container:
- e) electronic fuel management; and
- f) f)—refuelling receptacles.

NOTE 1 It is recognized that miscellaneous component properties not specifically addressed herein can be examined for compliance with the criteria of any applicable part of the ISO 22760 series, including subjecting the component to appropriate functional tests.

NOTE 2 All pressures referred to in this document are gauge pressures unless otherwise specified.

discharge pressure

pressure at which the pressure relief valve begins to open to relieve pressure upstream of valve

Note-1-to-entry:—_____This concept is also sometimes referred to as "cracking" or "opening" pressure.

4 Marking

Marking of the component shall provide sufficient information to allow the following to be traced:

- a) a) the manufacturer's or agent's name, trademark or symbol;
- b) b) the model designation (part number);
- c) c) -the working pressure or working pressure and temperature range; and
- d) d) the discharge pressure.

The following additional marking entries are recommended:

- — the direction of flow (when necessary for correct installation);
- — the electrical rating (if applicable);
- -https://the symbol of the certification agency; o/1e9f625c-d6bf-447c-a39d-9cf42fb143d7/iso-prf-22760-6
- — the type approval number;
- the serial number or date code; and

— — a reference to this document.

NOTE This information can be provided by a suitable identification code on at least one part of the component when it consists of more than one part.

5 Design and assembly

The pressure relief valve (PRV) shall comply with the applicable provisions of ISO 22760-<u>1</u> and ISO 22760-<u>2</u>, and pass the tests specified in Clause 6. Clause 6.

Additional requirements to the design of the PRV and to its assembly with other fuel system components are as follows:

 — mounting location of the PRV relative to the fuel container geometry and positioning in use is such that the contact of the PRV inlet with the liquid phase of the fuel is avoided as much as possible;
