

AMENDMENT 107: Safety sign M055 : Keep out of reach of children

Add safety sign M055 to the alphabetical summary in Table 1 and to category M in Tables 2 and 5 as follows:



Safety sign M055: Keep out of reach of children

Some items can be hazardous to children, resulting in serious injury or death if accessed by the child Human behaviour that is intended to be caused after understanding the safety sign's meaning

Adults keeping the item out of the reach of children

Additional information

Test data obtained according to ISO 9186-1:2014 are available from more than one country. Findings from testing showed that the safety sign exceeded the criteria of acceptability. A supplementary text sign may be used to increase comprehension. If the safety sign is supplemented by manuals, instructions or training, a supplementary text sign may not be required.
