This document will supersede EN 13586:2020.

prEN 13586:2025 includes the following significant technical changes with respect to EN 13586:2020:

- updating of normative references;
- revision of grammar and linguistic consistency;
- revision of List of significant hazards and its move to Annex A;
- re-numbering of clauses and Annexes;
- revision and update of Table A.1;
- revision of Annex ZA.

This document has been prepared under a standardization request addressed to CEN by the European Commission. The Standing Committee of the EFTA States subsequently approves these requests for its Member States.
