## Introduction

Understanding the official roles of persons acting on behalf of organizations is an important consideration in fulfilling both commercial business and regulatory interactions and obligations. This is especially true for engagements and interactions in the digital world, and in financial services in particular, as we move towards creating and sustaining a global digital economy.

This document addresses the need for listing official organizational roles in a structured way in order to specify the roles of persons acting officially on behalf of an organization or legal entity.

Key provisions of this document include:

- providing lists of official organizational roles;
- leveraging the experience of ISO/TC 68 in defining and maintaining reference data standards;
- defining an official organizational role scheme that is extensible and free from limitation on use and redistribution.

ISO/TC 68 sees that this document can be used to specify in a standard way the optional role extension contained in X.509 (ISO/IEC 9594-8) public key certificates with embedded LEIs, as outlined in ISO 17442-2.

This document can also be used to indicate roles in a standard way in digital verifiable credentials, the format for interoperable, cryptographically verifiable digital credentials being defined by the W3C standards organization.

Combining LEIs with official organizational roles can become a key enabler for digital identity management.

# Financial services — Official organizational roles — Scheme for official organizational roles

## 1 Scope

This document specifies an unambiguous scheme to list official organizational roles by jurisdiction in a standard way.

It is not the purpose of this document to compare or align official organizational roles across different countries or jurisdictions, so as not to limit the usage or relevance of this document. To understand the powers associated with each official organizational role, users of this document can consult applicable regulation or legislation, documents of the legal entity in which the official organizational role exists and procedures specific to each organizational entity.

## 3 Terms and definitions

For the purposes of this document, the following terms and definitions apply.

### 3.1

#### **official organizational role**

official role of a person within an organization or legal entity within a particular jurisdiction that is publicly discoverable in formation, registration or other official documents of the organization or legal entity

### 3.2

#### **legal entity**

legal person or structure that is organized under the laws of any jurisdiction

### 3.3

#### X.509

digital certificate used in many internet protocols, including TLS/SSL

## 4 Official organizational role code structure

The official organizational role code is an alphanumeric code of six characters from the basic Latin character set.

Alphabetic characters are uppercase letters A to Z, without accents (e.g. À, É, Ö, Ñ) and excluding “special” characters such as blanks, separators or punctuation.

Numeric characters are integers within the range 0 to 9.

Codes comprising solely numeric characters will be reserved and not assigned by the maintenance agency.

An official organizational role code contains no embedded intelligence regarding the identification of the role to which it applies. This document does not compare or align roles across different countries or jurisdictions. A unique official organizational role code will be assigned for every role identified using this document.

**EXAMPLE** A chief executive officer (CEO) in one country or jurisdiction is assigned an official organizational role code of G6D83R, whereas an equivalent or similarly named role in another country or jurisdiction is assigned an official organizational role code of CS2604.

## 5 Official organizational role data record (standards.iteh.ai)

The official organizational role data record shall be composed of the following minimum data attributes:

- Name(s) of the official organizational role, with the following components present for all relevant official local languages of the country and/or jurisdiction of formation:
  - name and language of the official organizational role;
  - transliterated name of the official organizational role represented in ISO 01-140-10, where applicable;
  - abbreviation of the official organizational role in the local language;
  - transliterated abbreviation of the official organizational role.
- Country and jurisdiction applicable to the role as represented in ISO 3166-1 for countries and ISO 3166-2 for subdivisions.
- Entity legal form (ELF) code represented in ISO 20275.
- Date created, as represented in ISO 8601.
- Role status: whether the role is in current use or inactive.
- Modification of the official organization role data record, with the following components:
  - modification date, as represented in ISO 8601.
  - modification reason: reason(s) official organizational role data record was modified.
- Applicable regulation and/or legislation regarding the official organizational role.

The official organizational role data record shall be structured in accordance with [Table 1](#) in relation to the minimum set of data attributes.

## 6 Maintenance

A maintenance agency established by the ISO council acts in accordance with procedures approved by the council. It has been entrusted with the following functions:

- to publish and disseminate official organizational role data records;
- to establish, in the normal course of work, additional rules for the practical application of the principles for issuing and maintaining official organizational role data records.
