Commercial road vehicles — Ball-bearing turntable — Interchangeability

1 Scope

This document specifies dimensions of ball-bearing turntable when mounted on a vehicle which is part of vehicle combinations specified in of ISO 18868:2013, Clause 4, to ensure their interchangeability.

This document also applies to the following:

- drawbar trailers using a ball-bearing turntable to steer the front axle;
- ball-bearing turntables assembled with the fifth-wheel of the road tractor (truck) to improve steering manoeuvre.




Figure 1 — Example of ball-bearing location

4 Standard ball-bearing turntables geometrical requirements

4.1 Radial section




Figure 2 — Radial section types

The radial section shall be one of the types shown in <u>Figure 2</u>. Dimensions of the types shall be according to <u>Table 1</u>. Dimensions not specified are left to the discretion of the component manufacturer.
