Introduction

Most healthcare assistive products for tissue integrity when lying down (APTIs) include a polyurethanecoated protective, waterproof, moisture vapour permeable cover, which is designed to protect the internal components of the APTI from damage, while still allowing the tissue integrity functions of the APTI to be effective.

As a class of materials, polyurethanes are very varied - from hard plastics used in ski-boots and car suspension components to stretchy elastomers used in wound dressings and APTI covers. Even the stretchy elastomers used for the APTI cores and covers incorporate a wide variety of polymer chemistry offering different characteristics.

Polyurethane APTI covers are 'soft surfaces', and even the most chemically resistant types are not immune to the aggressive ingredients used in some disinfectants used to treat 'hard surfaces'.

Furthermore, polyurethane APTI covers are more vulnerable to abrasion when wet.

These guidelines for handling APTI polyurethane covers are intended to lead to less damage to the covers and a longer life for the APTI. Other aspects relating to the materials, effectiveness, and durability of APTIs are covered in other parts of the ISO 20342 series.

1 Scope

This document provides guidance around best practices for cleaning, disinfecting and caring for the polyurethane covers for assistive products for tissue integrity when lying down (APTIs) where the covers are designed to protect the internal components of the APTI from damage. Adherence to this guidance will extend the operational life of the APTI and its tissue integrity performance.

This document gives guidance for cleaning and disinfecting by manual means only.

This document is not intended to give guidance related to the efficacy of the cleaning and disinfection procedures.

4 Cleaning, disinfection and care

4.1 General

To maintain the APTI cover's performance and integrity, the manufacturer's instructions on the cleaning, disinfecting and care of their product should take precedence over general instructions from cleaning/disinfectant suppliers.

NOTE 1 Failure to follow the instructions can compromise the performance of the APTI, can increase the risk of patient harm and can void product warranty.

NOTE 2 Prevention of serious disease transmission can require more aggressive interventions.

4.2 Cleaning

4.2.1 General

Cleaning and disinfecting are separate processes. Cleaning shall precede disinfection. Between patients: clean, disinfect, and check the product for proper functioning.

4.2.2 Cleaning process

- a) Physically remove blood and gross soiling using non-abrasive means.
- b) Wipe all exposed surfaces with pH neutral detergent (avoid using pH <6 and >8).
- c) Rinse thoroughly with clean, warm (typically from 18 °C to 40 °C) water and a clean cloth or sponge.

At all steps in the process, in the absence of manufacturer's instructions on cleaners and sponges or cloths, non-abrasive hospital-approved cleaners and sponges/cloths shall be used. https://standards.iteh.ai/catalog/standards/sist/3dc810e3-3e05-4e9b-9d86-

4.3 Disinfection

4.3.1 Disinfection process

- a) Wipe all exposed surfaces with disinfectant and leave for the recommended time.
- b) Wipe the surfaces dry.
- c) Rinse thoroughly with clean warm water (typically from 18 °C to 40 °C) using a clean cloth or sponge.
- d) Ensure the APTI is dry before linens are added.

4.3.2 Further considerations

Frequent applications of some disinfectants combined with a failure to rinse and dry increase the exposure to the active ingredients, which will accelerate the degradation of the APTI cover and thereby risk allowing fluids to pass through the cover. Compromised covers also increase cross-infection risk.

If some disinfectants are left to dry without rinsing, the chemical residue can be reactivated on contact with other fluids or the next cleaning cycle. Partially dissolved residue can be abrasive, leading to APTI cover damage.

NOTE Sensitive patients can develop dermatitis secondary to this residue reactivation.

4.4 Care of APTI covers

4.4.1 Storage

When the covers remain on the APTI during storage, the APTI should be:

- a) stored in an air-permeable protective cover, ideally in a normal indoor temperature and humidity environment;
- b) stored flat and not on their edge and without other objects such as side rails or bed ends on top;
- c) handled by two people to avoid dragging or pulling by its cover;
- d) transported on a bed or cart suitable for the purpose.

4.4.2 Before use

Inspect the APTI cover for damage, such as pinholes, tears, or cracks in the material, and replace it if necessary.

Ensure that the APTI is suitable for the intended patient in terms of:

- a) risk assessment;
- b) pressure redistribution;
- c) safe working load of the mattress, NDARD PREVIEW
- d) proper fit on the intended frame (to reduce the risk of entrapment).

4.4.3 Damage preventionISO/PRF TS 20342-10

- a) Take care not to puncture the cover as this will permit fluid ingress to contaminate the internal components.
- b) Do not place sharp objects, such as scissors, needles, syringes, scalpels, or other sharp objects, on the APTI cover.
- c) Remove or cover hand jewellery, including rings with sharp edges, to prevent damage to the APTI cover.
- d) Take extra care when using medical equipment, such as monitors, IV poles, side rails, transfer boards, X-ray cassettes, etc., to prevent damage to the APTI cover.
- e) Do not store medical equipment, IV poles, IV pumps, negative pressure wound therapy devices, bed parts, etc., on top of the support surface due to the risk of tearing the APTI cover.
- f) When using slings, slide sheets and transfer devices, take care to ensure that buckles do not scratch or snag the APTI cover during use.
- g) Periodically, if possible, open and lift the cover to inspect the inside of the cover and the internal components for breaches and/or contamination.
- h) Damaged covers and internal components should be replaced according to the manufacturer's guidelines.
