Thiourea (CAS No. 62-56-6), as a kind of chemical raw material, is widely used in the manufacture of drugs, dyes, resins, compression plastic powder, etc., and can also be used as vulcanization accelerator for rubber and flotation agent for metal minerals, especially in the field of high-folding optical resin materials. China has developed corresponding industry standard (HG/T 3266-2019)<sup>1)</sup>. This document is prepared with reference to the standard.
