Re-number the current NOTE in 6.3.2 to NOTE 1 and add the following NOTE 2 at the end of the subclause:

NOTE 2 For some resin glues, it can be necessary to roughen portions of the articulating surface of the head to increase the attachment strength between the glue and the articulating surface to prevent failure of that interface during the test.

6.3.3

Re-number the current NOTE in 6.3.3 to NOTE 1 and add the following NOTE 2 at the end of the subclause:

NOTE 2 For some cast resins, it can be necessary to roughen portions of the articulating surface of the head to increase the attachment strength between the cast resin and the articulating surface to prevent failure of that interface during the test.
