**6.1 Test bearings**, double row self-aligning bearings in accordance with DIN 630, such as SKF1306K/236725<sup>1)</sup> with a steel cage, specially inspected, protected with a waxy type corrosion inhibitor (no preservative with chemical rust inhibitor) and packed.

NOTE It is possible that a chemical rust inhibitor containing preservative is not completely eliminated during the washing procedure, thus leaving some corrosion protection and possibly introducing bias in the test.
