This seventh edition cancels and replaces the sixth edition (ISO 2004:2017), which has been technically revised.

The main changes are as follows:

- the reference to ISO 8053 has been replaced by ISO 6101-3 in Clause 2 and in Table 1;
- type XA has been replaced by type MA in 3.4 and in Table 1;
- the total solid content of the creamed type latex has been added in 3.5 and in 3.6;
- the total solids content for type HA creamed and type LA creamed in <u>Table 1</u> has been changed from "65,0 %" to "65,0 % or as agreed between the two parties".
