Standard Specification for Reclaimed 1,1,2-Trichloro 1,2,2-Trifluoroethane¹

This standard is issued under the fixed designation D5248; the number immediately following the designation indicates the year of original adoption or, in the case of revision, the year of last revision. A number in parentheses indicates the year of last reapproval. A superscript epsilon (ε) indicates an editorial change since the last revision or reapproval.

1. Scope

1.1 This specification covers the three grades of 1,1,2trichloro 1,2,2-trifluoroethane² typically needed in various industries. It may be used as a reference document by purchasers or by persons establishing in-house, 1,1,2-trichloro 1,2,2trifluoroethane recovery programs.
