Standard Specification for Nickel-Molybdenum-Chromium-Iron Alloys (UNS N10003, UNS N10242) Plate, Sheet, and Strip¹

This standard is issued under the fixed designation B434; the number immediately following the designation indicates the year of original adoption or, in the case of revision, the year of last revision. A number in parentheses indicates the year of last reapproval. A superscript epsilon (ϵ) indicates an editorial change since the last revision or reapproval.

1. Scope

- 1.1 This specification² covers nickel-molybdenum-chromium-iron alloys (UNS N10003 and UNS N10242)*N10242) plate, sheet, and strip for use in general corrosive service.
 - 1.2 The following products are covered under this specification:
- 1.2.1 *Sheet and Strip*—Hot or cold rolled, annealed, and descaled unless annealing is performed in an atmosphere yielding a bright finish.
 - 1.2.2 Plate—Hot rolled, annealed, and descaled.
- 1.3 The values stated in inch-pound units are to be regarded as standard. The values given in parentheses are mathematical conversions to SI units that are provided for information only and are not considered standard.
- 1.4 This standard does not purport to address all of the safety concerns, if any, associated with its use. It is the responsibility of the user of this standard to become familiar with all hazards including those identified in the appropriate Material Safety Data Sheet (MSDS)(SDS) for this product/material as provided by the manufacturer, to establish appropriate safety and health practices, and determine the applicability of regulatory limitations prior to use.
