## Standard Specification for Low Toluene Low Dioxane (LTLD) Benzene<sup>1</sup>

This standard is issued under the fixed designation D7185; the number immediately following the designation indicates the year of original adoption or, in the case of revision, the year of last revision. A number in parentheses indicates the year of last reapproval. A superscript epsilon ( $\epsilon$ ) indicates an editorial change since the last revision or reapproval.

### 1. Scope\*

- 1.1 This specification covers a grade of benzene known as Low Toluene Low Dioxane (LTLD) Benzene.
- 1.2 The following applies to all specified limits in this standard: for purposes of determining conformance with this standard, an observed value or a calculated value shall be rounded off “to the nearest unit” in the last right-hand digit used in expressing the specification limit, in accordance with the rounding-off method of Practice E29.
- 1.3 The values stated in SI units are to be regarded as the standard. The values given in parentheses are for information only.
- 1.4 Consult current OSHA regulations, ~~supplier’s Material~~ supplier’s Safety Data Sheets, and local regulations for all materials used in this specification.
